Cyflwyniad a chroeso Cafodd yr aelodau eu croesawu i Geredigion gan y Cynghorydd Catherine J Hughes o Gyngor Sir Ceredigion, a gyflwynodd ddisgyblion o ddwy ysgol a oedd wedi paratoi cyflwyniadau ar gyfer y cyfarfod. Diolchodd y Cadeirydd i'r ddwy ysgol am eu cyflwyniadau pleserus, a oedd yn ddeunydd i ysgogi'r meddwl.

Fodd bynnag, yr oedd cynlluniau'n bodoli ar gyfer adolygiad gan Lywodraeth Cymru o bob pwnc, gan gynnwys AG, yn y dyfodol agos. Codwyd pryderon gan rai aelodau ynglŷn â gallu athrawon i ymdopi â phwysau paratoi eu portffolios. Adleisiodd Mary Parry'r pryder, ond gwnaeth y sylw nad oedd modd gwneud dim pellach oherwydd mai'r dyddiad cau ar gyfer y portffolios oedd 30 Mawrth.

Mynegodd Paula Webber (Blaenau Gwent) bryder bod athrawon, wrth bennu lefel ar gyfer gwaith, fel rheol yn defnyddio dull 'ffit orau', a oedd yn wahanol i ofynion y broses safoni. Hefyd, yr oedd y broses safoni wedi cymryd mwy o amser nag yr oedd y tîm safoni wedi ei ragweld.

Minutes of the Wales Association of SACRE meeting, County Hall, Ceredigion, 30 March 2012

- 1. Introduction and welcome Cllr Catherine Hughes from Ceredigion County Council welcomed members to Ceredigion and introduced pupils from two schools who had prepared presentations for the meeting. The Chair thanked the two schools for their enjoyable and thought-provoking presentations.
- **2. Quiet reflection** The Chair led the reflection, which focused on the importance of not judging people on the way they look.
- **3. Apologies** Chris Abbas, Mark Brown, Susan Cave, Gavin Craigen, Rameez Delpak, Michael Gray, Bethan James, Jen Malcolm, Denize Morris, Janet Neilson, Brian Rogers, John Rogers, Nigel Steele-Mortimore, Helen Gibbon
- **4. Minutes of the last meeting** With a correction to page 1 for attendance, Meinir Wynne Loader, the minutes were accepted as a correct record of the meeting.
- 5. Matters arising Page 2, point 4: KS3 Moderation. TaS highlighted key points from the response from Leighton Andrews about KS3 Moderation. It was emphasised that it was not possible to extend the time for KS3 Moderation in RE. However, there were plans for a Welsh Government review of all subjects, including RE, in the near future. Concern was raised by some members about teachers coping with the pressure of preparing their portfolios. Mary Parry echoed the concern, but pointed out that nothing further could be done because the deadline for the portfolios was 30 March.

Paula Webber (Blaenau Gwent) expressed concern that when teachers level work, they normally use a 'best fit' approach, which is different to the requirements of the moderation process. The moderation process has also taken longer than has been anticipated by the

Mynegodd Joyce Howells (Sir Gaerfyrddin) bryder nad oedd amser wedi ei roi i staff nac adrannau unigol i gwblhau'r dasg, ac mai hyn oedd wedi cyfrannu'n bennaf at yr anawsterau. Siaradodd Phil Lord (Sir y Fflint) am y modd yr oedd y broses wedi bod yn un gadarnhaol i raddau helaeth o ran agor trafodaeth ynglŷn â beth oedd AG 'dda'. Siaradodd Carvs Pritchard am bwysigrwydd CYSAGau Lleol a'r cymorth yr oeddynt yn ei roi i ysgolion yn dilyn y deilliannau safoni. Codwyd pryderon hefyd ynglŷn â sut y byddai safonwyr yn ymdopi â nifer y ceisiadau a fyddai'n cael eu cyflwyno. Eglurodd Phil Lord fod CBAC yn ymwybodol o nifer y ceisiadau, a'u bod wedi trefnu nifer digonol o safonwyr i ymdopi â'r galw. Cododd Gill Vaisey a Vicky Thomas bryder ynglŷn â chymorth ar gyfer ysgolion nad oedd yn 'pasio'. Awgrymwyd y gellid 'uwchsgilio' yr athrawon/adrannau hynny yn yr un modd ag yr 'uwchsgiliwyd' rhai o'r safonwyr er mwyn safoni ysgolion eraill yn effeithiol.

Cynigiodd y Cadeirydd y dylid cyfeirio'r mater hwn at Bwyllgor Gwaith CCYSAGauC ac at PYCAG am drafodaeth bellach. Dywedodd Gill Vaisey fod PYCAG yn edrych ar y disgrifwyr lefelau ar hyn o bryd . Dywedodd Tania ap Siôn y byddai CCYSAGauC yn gweithio gyda PYCAG ar fater cynorthwyo athrawon yn dilyn y broses safoni CA3. Cododd Rheinallt Thomas (Ynys Môn) y pwynt y buasai o gymorth i GCYSAGauC ofyn i Gavin Craigen (y Prif Safonwr) wneud cyflwyniad ynglŷn â chanlyniadau'r safoni mewn cyfarfod o GCYSAGauC yn y dyfodol. Siaradodd Meinir Wynne Loader (Sir Gaerfyrddin) o safbwynt athrawon, a mynegi pryder ynglŷn â'r straen yr eid iddo o ganlyniad i'r broses, a'r diffyg hyder a morâl isel a oedd yn gysylltiedig â hynny. Adleisiwyd hyn gan Joyce Howells (Ceredigion).

Tudalen 3, pwynt 6: mater cynrychiolwyr ar GYSAGau, gyda golwg ar ohebiaeth gan Gymdeithas Dyneiddwyr Prydain (BHA). Yr oedd ymateb i GCYSAGauC wedi ei dderbyn oddi wrth Lywodraeth Cymru; nid oedd LlC yn

moderation team. Joyce Howells (Carmarthenshire) expressed concern that time had not been given to individual staff or departments to complete the task and it is this that had largely contributed to the difficulties. Phil Lord (Flintshire) spoke about how the process had been largely positive in opening up a discussion about what is 'good' RE. Carys Pritchard spoke of the importance of Local SACREs and the support that they give to schools following the moderation outcomes. Concerns were also raised about how moderators would cope with the volume of applications that would be submitted. Phil Lord explained that WJEC were aware of the amount of applications and have arranged for an adequate number of moderators to cope with demand. Gill Vaisey and Vicky Thomas raised the concern of support for schools that do not 'pass'. Suggestions were given of 'upskilling' those teachers/departments in the same way that some of the moderators have been 'up-skilled' in order to moderate other schools effectively.

The Chair proposed that this issue be referred to the WASACRE Executive Committee and NAPfRE for further discussion. Gill Vaisey said that NAPfRE were currently looking at the level descriptors. Tania ap Sion said that WASACRE would work with NAPfRE on the issue of teacher support following the KS3 Moderation process. Rheinallt Thomas (Anglesey) raised the point that it would be helpful for WASACRE to ask Gavin Craigen (Chief moderator) to deliver a presentation of the moderation results at a future WASACRE meeting. Meinir Wynne Loader (Carmarthenshire) spoke from a teacher perspective and expressed concern about the stress incurred as a result of the process and associated lack of confidence and low morale. This was echoed by Joyce Howells (Ceredigion).

Page 3, point 6: the issue of representation on SACREs, with reference to the British Humanist Association correspondence. A response from the Welsh Government to WASACRE had been received; the WG was

Cadarnhaodd Tania ap Siôn fod sylw'r holl GYSAGau wedi ei dynnu at y ddeiseb a oedd yn cefnogi addoli ar y cyd, ac at ei chyd-destun (hynny yw, fel ymateb i ddeiseb a osodwyd ar y safle gan gynrychiolydd o Gymdeithas Dyneiddwyr Prydain yn cefnogi adolygiad o'r gofynion cyfreithiol cyfredol am addoli ar y cyd).

6. Y ddogfen addoli ar y cyd Eglurodd y Cadeirydd y sail resymegol a fu'n gefndir i greu'r ddogfen, a diolchodd i Tania ap Siôn am ei gwaith yn ei chynhyrchu. Cyflwynodd TaS y copi drafft o'r ddogfen, ac eglurodd ei phwysigrwydd. Byddai'r ddogfen, ar ôl ei chwblhau, yn cael ei chylchredeg i'r holl GYSAGau i'w dosbarthu i'r holl ysgolion. Siaradodd aelodau o blaid addoli ar y cyd. Diolchodd Carys Pritchard i bawb a oedd wedi bod yn gysylltiedig â chreu'r ddogfen hon, gan gynnwys yr astudiaethau achos a'r adnoddau a fyddai ar gael ar wefan CCYSAGauC.

Pwysleisiodd y Cadeirydd mai dogfen ddrafft ydoedd, ond y byddai'n cael ei chylchredeg i GYSAGau'n fuan.

Pwysleisiodd Ben Wigley (MAGC) yr angen i'r ddogfen fod yn eiddo cyhoeddus cyn gynted ag yr oedd modd, boed yr astudiaethau achos a'r adnoddau eraill ynghlwm wrthi ai peidio. Gofynnodd hefyd am i'r ddogfen gael ei hanfon at Benaethiaid ysgolion, gan mai eu cyfrifoldeb hwy oedd hi. Ychwanegodd y Cadeirydd y dylid ei hanfon hefyd at Gadeirydd Llywodraethwyr pob ysgol, a oedd hefyd â chyfrifoldebau cysylltiedig.

unable to advise WASACRE on this issue, but pointed to the existing legislation relating to the composition of SACREs. Tania ap Sion said that there had been no changes to current legislation, which stated clearly that Committee A was for representatives from religious faith communities; however, a representative of the BHA could be co-opted to local SACREs if this were considered appropriate.

Rheinallt Thomas spoke about the web-based collective worship petition on the Welsh Government website and asked whether all SACREs were aware of it. Tania ap Sion confirmed that all SACREs had been alerted to the petition supporting collective worship and to its context (that is, as a response to a petition placed on the site by a representative of the British Humanist Association supporting a review of the current legal requirements for collective worship).

6. Collective worship document The Chair explained the rationale behind the creation of the doc and thanked Tania ap Sion for her work in producing it. TaS introduced the draft copy of the document and explained its importance. The document, when completed, would be circulated to all SACREs for distribution to all schools. Members spoke in support of collective worship. Carys Pritchard thanked everyone concerned in the creation of this document, including the case studies and resources that will be available on WASACRE website.

The Chair emphasised that it was a draft document but would be circulated soon to SACREs.

Ben Wigley (REMW) emphasised the need for this document being in the public domain as soon as possible, with or without the case studies and other resources. He also asked for the document to be sent to the Heads of schools, as it is their responsibility. The Chair added that it should also be sent to each school's Chair of Governors, who also carries responsibility. Vicky Thomas proposed that a

**7. AtGyfnerthu** Atgoffodd Tania ap Siôn yr aelodau am y cytundeb y byddai fersiwn cryno o'r adroddiad AtGyfnerthu llawn, o safbwynt Cymreig, yn cael ei greu. Yr oedd hyn wedi ei wneud, ac yr oedd y crynodeb wedi ei anfon at Leighton Andrews (yr oedd copïau o'r adroddiad wedi eu cynnwys yn y papurau ar gyfer y cyfarfod). Yr oedd y Gweinidog wedi diolch i GCYSAGauC, ac wedi cydnabod llwyddiant a deilliannau cadarnhaol y prosiect AtGyfnerthu yng Nghymru. Y cam nesaf fyddai anfon y crynodeb o'r adroddiad at yr holl GYSAGau. Cefnogwyd hyn gan yr aelodau. Dywedodd Mary Parry y byddai holl ysgolion Cymru, ac nid yn unig y 40 o ysgolion Cymreig a fu'n gysylltiedig â'r broses, yn elwa o gael at ddeunyddiau'r prosiect AtGyfnerthu. Ymatebodd Tania ap Siôn drwy egluro bod trafodaethau'n digwydd yn y Cyngor AG ynglŷn â sut i drefnu bod yr adnoddau hyn ar gael. O safbwynt Cymru, yr oedd problemau ynglŷn â sut y byddai'r adnoddau'n cael eu diweddaru a'u cadw'n berthnasol i Gymru ac ysgolion Cymru. Fel aelod o Fwrdd y Cyngor AG, byddai Tania ap Siôn yn sicrhau bod y newyddion diweddaraf gan yr aelodau bob amser; yr oedd hwn yn faes y byddai angen ei drafod ymhellach yng NghCYSAGauC a PYCAG.

Gofynnwyd cwestiynau ynglŷn â faint o ysgolion

copy is sent to Estyn, so that they are aware of what guidance is being given to schools. Gill Vaisey and Phil Lord emphasised the need to get the case studies available as soon as possible so that those teachers who will be working on Collective Worship over the summer will have access to them. Tania ap Sion said that the document could be put on the WASACRE website as soon as it is available. Mary Parry suggested that the document be placed on the website immediately and with case studies being added as and when completed. There were no objections to this proposal. Related to collective worship, Rheinallt Thomas raised a concern that Estyn inspectors may be interpreting the standards and requirements for collective worship differently

and this had an impact on individual schools.

7. REsilience Tania ap Sion reminded members that it had been agreed that a summarised version of the full REsilience report from a Welsh perspective would be created. This had been done and sent to Leighton Andrews (copies of the report were included in the papers for the meeting). The Minister has thanked WASACRE for the report and recognised the success and positive outcomes from the REsilience project in Wales. The next step would be to send the summary of the report to all SACREs. Members supported this. Mary Parry said that all schools in Wales would benefit from access to the REsilience project materials and not just the 40 schools who were involved in the process in Wales. Tania ap Sion responded by explaining that discussions were taking place in the RE Council concerning how to make these resources available. From a Welsh perspective, there were issues concerning how the resources would be updated and remain relevant to Wales and Welsh schools. As a Board member of the RE Council, Tania ap Sion would keep members up-to-date and that this was an area which would need further discussion in WASACRE and NAPfRE.

Questions were asked about how many Welsh-

8. Cyflwyniad PYCAG: Newidiadau i'r Fanyleb ar gyfer AG yn TGAU (Tudor Thomas) Diolchodd TT i GCYSAGauC am ei wahodd i roi'r cyflwyniad, a dosbarthwyd taflen o'r cyflwyniad PowerPoint i'r aelodau. Rhoddwyd gwybod i'r aelodau am y newidiadau ynglŷn â marcio sillafu, atalnodi a gramadeg, yn ogystal â newidiadau i asesu.

Diolchodd y Cadeirydd i TT am ei gyflwyniad. Cododd Paula Webber fater disgyblion â dyslecsia a oedd yn cael eu 'cosbi' am eu hanabledd oherwydd SPAG. Ymatebodd Tudor drwy ddweud ei fod yn ymwybodol o'r mater hwn ac yn deall y pryder, ond eglurodd na fyddai caniatâd, o dan y canllawiau presennol, i CBAC wneud trefniadau arbennig ar gyfer disgyblion â dyslecsia (heblaw'r rhai sydd eisoes yn eu lle).

Cododd Mary Parry bryder ynglŷn â'r anawsterau o ran cael at ddata ynglŷn ag arholiadau eleni. Pwysleisiodd mai un o gyfrifoldebau'r CYSAGau oedd monitro safonau mewn arholiadau. Yr oedd angen y data er mwyn darparu dadansoddiad llawn a chywir. Adleisiodd Carys Pritchard y pryder hwn, a phwysleisiodd yr angen i gymharu safonau mewn ysgolion cyffelyb ar draws y wlad, a bod hyn yn cynnwys y data cymharol ar fechgyn a genethod. Gofynnodd Rheinallt Thomas am i lythyr gael ei anfon at Lywodraeth Cymru ynglŷn â hyn, ac ynglŷn â'r problemau yr oedd wedi eu hachosi. Cynigiodd Carys Pritchard a Mary Parry y dylai'r llythyr gael ei anfon gan GCYSAGauC ar ran y CYSAGau. Cytunodd yr aelodau i hyn. Pwysleisiodd y Cadeirydd y gallai CYSAGau unigol ddal i ysgrifennu at Leighton Andrews ynglŷn â'r mater hwn. Ymatebodd Tudor Thomas nad oedd y contract gyda CBAC bellach, ond gyda chwmni yn yr Alban. Byddai'n

medium schools were involved and when the evaluation feedback would be shared. Tania ap Sion said that Welsh medium schools were involved, but could not give an exact figure without checking. There had been an attempt to retrieve evaluation forms from participating schools and more work was being done to retrieve more evaluation forms.

# 8. NAPfRE presentation: Changes to the GCSE RE Specification (Tudor Thomas).

TT thanked WASACRE for inviting him to give the presentation and members were given a hand out of the PowerPoint presentation. Members were informed about the changes relating to the marking of spelling, punctuation and grammar, as well as changes to assessment.

The Chair thanked TT for his presentation. Paula Webber raised the issue of pupils with dyslexia being penalised for their disability because of SPAG. Tudor responded, saying he was aware of this and understood the concern, but explained that under the current guidelines the WJEC would not be allowed to make special arrangements for pupils with dyslexia, other than those already in place.

Mary Parry raised a concern about the difficulties accessing examination data this year. She emphasised that one of the SACRE's responsibilities is to monitor standards in examinations. The data is needed to provide a full and accurate analysis. Carys Pritchard echoed this concern and emphasised the need to compare standards in similar schools across the country and that this included the comparative data for boys and girls. Rheinallt Thomas asked for a letter to be sent to the Welsh government about this and the problems it has caused. Carys Pritchard and Mary Parry propose the letter is sent from WASACRE on behalf of the SACREs. This was agreed by members. The Chair emphasised that individual SACREs could still write to Leighton Andrews on this issue themselves. Tudor Thomas responded that the contract was now not with WJEC, but a

company in Scotland. He will take this back to WJEC and ask how this could be rectified.

**9. RE Council report** Tania ap Sion referred to the WASACRE Executive meeting where it was proposed that there should be a reintroduction of the RE Council report at WASACRE meetings including items which are of relevance to Wales. This will now be a regular item on the WASACRE agenda.

REQM (RE Quality Mark): Tania ap Sion explained the purpose of the Quality Mark. It is an accreditation system, which recognises good practice in religious education in schools. Schools which gain the mark will be expected to share good practice with other schools, to support good quality provision of RE. The REQM is being developed in England this summer and autumn.

WASACRE has been asked if Wales would be interested in being part of this initiative.

Interest was shown by members and it was agreed that this should be explored further at the next WASACRE Executive meeting.

10. NAPfRE Presentation: Learning outside the classroom (Phil Lord, Debbie Humphreys, Owen Edwards) The presentation was concerned with a collaborative project comprising Bangor Cathedral, CYNNAL, Conwy Local Authority and the St Mary's Centre. The project set out to explore the impact of a cathedral activity day about Advent and Christmas on participating primary school children from seventeen local primary schools. An evaluation of the impact of the experience and a research report from St Mary's Centre discussed the impact in detail. Philip Lord (Conwy LA) introduced and described the project. Tania ap Sion (St Mary's Centre) presented the research findings of the project on behalf of Owen Edwards. Debbie Humphreys (Cynnal) spoke about curriculum support material created by Cynnal for 'What is the meaning of Christmas' which complements the work which had been done in Bangor Cathedral. This support material is

However, if anyone requires transportation from the station, please let the Secretary know so that arrangements can be made.

The Chair concluded the meeting by thanking Cllr Catherine Hughes for her welcome, the schools and colleagues who gave presentations, Denfer Morgan (Clerk to SACRE), the catering staff, Ceredigion Council and staff for their hospitality.



# GUIDANCE ON COLLECTIVE WORSHIP WALES ASSOCIATION OF SACRES

#### **June 2012**

#### INTRODUCTION

School acts of collective worship are educationally meaningful when they provide opportunities to engage with the needs of all learners, whatever their faith or belief background. Good collective worship promotes spiritual development, contributes to personal development, benefits the whole school community, links the school community and the wider local community, and enhances awareness of global citizenship.

Some factors underpinning effective collective worship include:

- developing a coherent school policy and approach to collective worship, with active engagement from senior management;
- creating collective 'ownership' of the school's programme of collective worship on the part of staff, learners and governors;
- ensuring that there are clear expectations among staff concerning their contributions to collective worship;
- offering opportunities for learners to actively engage in collective worship;
- making collective worship an integral part of the school day by reflecting in planning its relevance to and connections with all aspects of school life;
- providing continuing professional development opportunities for staff which will allow critical reflection on and enhancement of collective worship provision in the school.

In order to develop educationally meaningful and effective collective worship, it is important to appreciate the benefits of collective worship and to be familiar with the legal requirements relating to collective worship.

#### APPRECIATING THE BENEFITS OF COLLECTIVE WORSHIP

It would be useful for schools to discuss how collective worship promotes spiritual development, contributes to personal development, benefits the whole school community, links the school community and the wider local community, and enhances awareness of global citizenship.

## (a) Collective worship promotes spiritual development

Schools have a duty to promote the spiritual development of learners. Effective collective worship enables a school to contribute to this statutory requirement. It is important to understand that spiritual development or spirituality is **not** the same as being religious, but it is about the process of developing learners' appreciation of the spiritual dimensions of life and the wider issues of meaning, purpose and fulfilment. Staff and learners should appreciate that acts of collective worship:

- provide a special time separate from ordinary school activities;
- support learner-centred experiences, and enable learners to develop a sense of their position within the universal picture;
- develop learners' ability to reflect on their own feelings, values and attitudes;

- develop learners' awareness of the inner life and the spiritual dimension of each person;
- explore and encourage responses to fundamental questions about the meaning of life, change and death.

#### (b) Collective worship contributes to personal development

Schools have a duty to promote the personal development of learners.<sup>2</sup> Effective collective worship enables a school to contribute to this statutory requirement. Staff and learners should appreciate that acts of collective worship:

- contribute to health and wholeness, and emotional intelligence;
- encourage reflection on inner feelings and beliefs;
- develop beliefs and values, both personal and communal;
- encourage an understanding of the beliefs and values of others;
- increase self esteem and purpose in life;
- nurture the human ability to make moral choices for good or evil, through thinking about 'moral codes, relationships, responsibility, respect for diversity, temptation, the power of self, sacrifice and love'.<sup>3</sup>

## (c) Collective worship benefits the whole school community

Effective collective worship provides benefits for the whole school community. Staff and learners should appreciate that acts of collective worship:

- encourage shared values, meaning and purpose;
- contribute to the experience of belonging to a community;
- provide opportunities to celebrate the school's achievements and the contribution of individuals to those achievements;
- develop understanding and appreciation of the beliefs and values of others within the school community;
- provide opportunities to reflect on and to share in the 'happy' and 'sad' events and experiences which effect the school community;
- contribute to a school ethos which supports the educational attainment of all learners, regardless of background, through developing self esteem and a sense of purpose in life

#### (d) Collective worship links the school community and the wider local community

Schools are expected to consider how they support and promote community cohesion, and it should be recognised that collective worship offers a valuable contribution at both school level and wider community level. Effective collective worship makes links between the school community and the wider local community. Staff and learners should appreciate that acts of collective worship:

- draw on a range of carefully selected and appropriate representatives within the local community to contribute to collective worship;
- contribute to the experience of belonging to a wider local community;
- provide opportunities to celebrate the local community's achievements and the contribution of groups and individuals to those achievements;
- develop understanding and appreciation of the beliefs and values of others within the local community;
- support shared understanding of how individual learners and a school may contribute positively to the wider community;
- provide opportunities to reflect on and to share in the 'happy' and 'sad' events and experiences which effect the local community.

#### (e) Collective worship enhances awareness of global citizenship

Effective collective worship enhances awareness of global citizenship. Staff and learners should appreciate that acts of collective worship:

- draw on a range of carefully selected material to promote global awareness;
- contribute to the experience of belonging to a global community;
- provide opportunities to celebrate global events and human achievements;
- develop an understanding of global diversity and inequality;
- offer opportunities to reflect on and share in global crises and human suffering.

The whole school has much to gain from educationally meaningful and effective acts of collective worship, and members of the school (and local community) have much to offer through presentations and contributions to acts of collective worship. In practice, schools should consider how these benefits may be incorporated into their programme for collective worship and be collectively 'owned' by the whole school community.

#### COLLECTIVE WORSHIP AND THE LAW

The law distinguishes between 'schools with a religious character' and other schools which do not have a religious character (School Standards and Framework Act 1998). 'Schools with a religious character' are those linked with one or more Christian denominations or a major world faith by virtue of their foundation or by a specific legally binding decision to become such a school. The DfES maintains a list of such schools in Wales.

# (a) What the law really says about worship in state-maintained schools WITHOUT a religious character

- There is a statutory requirement for schools to provide a **daily** act of collective worship for all learners;
- This requirement is for **every learner** to have opportunity to participate in an act of collective worship **every day**;
- There is provision for learners to be withdrawn from acts of collective worship, at the request of parents;
- There is also provision for teachers to withdraw from conducting acts of collective worship;
- The majority of acts of collective worship in a school term and year should be 'wholly, mainly of a broadly Christian character', and in maintained schools, not solely of any one denomination;
- The majority of acts of collective worship should have elements in them which relate to traditions of Christian belief;
- Worship in a school context should be 'collective' rather than 'corporate';
- Acts of collective worship should not be passively received a response is required;
- For maintained schools, acts of collective worship must take place on the school premises;
- Schools have the right to a 'Determination' that is, to be released from the requirements for acts of worship to be wholly, mainly of a broadly Christian character, if the school composition might require this (applications are to be made to the local SACRE);
- Acts of worship are distinct from an 'assembly' which, in law, is actually any gathering of the school **apart from** collective worship;
- Since January 2009, post-16 learners may request withdrawal from collective worship for themselves.<sup>4</sup>

#### (b) What the law really says about state-maintained schools WITH a religious character

- There is a statutory requirement for schools to provide a **daily** act of collective worship for all learners;
- This requirement is for **every learner** to have opportunity to participate in an act of collective worship **every day**;
- There is provision for learners to be withdrawn from acts of collective worship, at the request of parents;
- There is also provision for teachers to withdraw from conducting acts of collective worship, however, there are some limitations to this right in Voluntary Aided schools;
- The acts of worship will reflect the religious character of the school;
- The acts of worship are likely to include material drawn from the worshipping practice and traditions of the specific faith or denomination with which the school is associated:
- Worship should be 'collective' not 'corporate';
- Acts of worship should not be passively received a response is required;
- Schools may use a local place of worship for some of its acts of worship where this is appropriate;
- Schools do not have the right to a determination;
- Acts of worship are distinct from an 'assembly' which, in law, is actually any gathering of the school **apart from** collective worship;
- Since January 2009, post 16 learners may request withdrawal from collective worship for themselves.<sup>5</sup>

#### (c) What the law does not say

There is often confusion about collective worship, and it is important to know that the law does **not** require:

- the **whole school** to be together for collective worship [The requirement is for any gathering of learners the school chooses, other than groupings based on religious affiliation]
- acts of collective worship to be **at the start of school** in the morning [The timing of collective worship in the school day is for each school to determine]
- a stated **length of time** for acts of collective worship [The length of acts of collective worship is a school matter, but should not reduce the expected hours of the curriculum day].

#### POTENTIAL ACTIONS

Schools which are serious about providing educationally meaningful and effective collective worship will:

- establish clear principles, policies and programmes to underpin acts of collective worship;
- create a collective sense of 'ownership' of collective worship;
- identify funding to provide training for staff or establish a professional learning community perhaps through a local consortium.

# RE for good – wide public support for RE in schools

New research published today reflects public endorsement for high quality Religious Education (RE) in our schools. Good quality RE is widely understood to be at risk of being squeezed out of the curriculum despite it being highly valued. This new research shows over half (53%) of all adults in England and Wales who gave an opinion say RE should remain a compulsory subject. 58% agreed it is beneficial for all pupils to participate in RE lessons. This rose to a majority (63%) among 18-24 year olds.

Today's research on attitudes to RE was conducted by YouGov on behalf of the Religious Education Council of England and Wales (REC) and results are announced as MPs prepare to attend the first meeting of the All Party Parliamentary Group on RE. The views of all those who expressed an opinion on RE are:

- Over half (53%) of all adults in England and Wales think that RE should remain a compulsory subject in state funded schools
- 58% think it is beneficial for pupils to study RE
- The above two percentages rise to 63% in each case among 18–24 year olds
- 1 in 2 adults think RE provides a valuable space in the school day where young people can learn about all religious and non-religious beliefs

With religious and non-religious diversity increasing, these figures reflect the value adults attach to young people being able to articulate their own beliefs, as well as engaging with, respecting and understanding others. 50% of those who gave an opinion said RE was an essential component of a multi-faith society, as it promotes mutual respect, tolerance and understanding. This rose to over half among 18-24 year olds (52%) and 25-34 year olds (56%). In contrast, only 9% said they thought it was 'harmful' for pupils to study RE and only 13% thought it should not be taught in schools at all.

Higher support among younger adults

RE has been on the curriculum since 1944 and in that time has changed from Biblical

study to include world religions and non-religious worldviews. For children and

young people, RE is an important opportunity in the school day when they are taught

to recognise and respond to the challenges of growing up in a diverse, multi-cultural

society. The research uncovered especially positive views of RE from those with

most recent experience of school:

Of those with an opinion, 60% of full time students agree RE is essential to a

multi-faith society (a rise on 50% of all adults)

65% of full time students agree that it is beneficial for pupils to study RE (a

rise on 58% of all adults)

In response to the survey and its findings John Keast, chair of the REC said:

"RE is a core part of the education system and we and our member bodies are

committed to offering all the support we can muster to help schools deliver high value

RE. Our ambition is to promote widespread understanding of how academically

rigorous and personally inspiring good RE can be and how it equips young people to

appreciate a range of religious and non-religious beliefs in our world. It's positive to

see such a strong belief in the importance of the subject among the public.

"As part of the REC's on-going commitment to ensure RE teaching keeps up with

proposed changes to the National Curriculum, we are working on a revised subject

framework for RE. We look forward to now working with MPs in the newly-formed All

Party Parliamentary Group on RE, informed by this new and encouraging research."

Report of the WASACRE Executive meeting 24 May 2012, Glyndŵr University, Wrexham

**Present:** Tania ap Sion (Chairing), Libby Jones (minutes), Bethan James, Brian Rogers, Brian Jones, Rheinallt Thomas, Dafydd Treharne.

- **1. Welcome** The Vice Chair welcomed Bethan James who replaces Gill Vaisey as Chair of NAPfRE and passed on apologies from the Chair of WASACRE (EE) and Michael Gray. The Vice Chair chaired the meeting in EE's absence.
- **2. Apologies** Edward Evans, Michael Gray, Vicky Thomas, John Mitson, Gavin Craigen, Mary Parry.
- **3. Minutes of last meeting** Minutes were accepted as a true record of the meeting.
- **4. Matters arising** Item 4. Foundation Phase document. It was confirmed that Confirmation no more information had been received about the publication date for this. TaS will email DM for an update.

Item 5. The Executive decided to follow up the issue of GCSE examinations in Wales changing from Modular to Linear model. LJ will write a letter to Leighton Andrews to enquire about the status of this decision. The letter will reiterate the importance and value of the GCSE course in delivering the core RE element to KS4, for many schools across Wales.

Members were alerted to the issue of the REsilience evaluations and the need for schools to complete these and send them back to TaS as soon as possible.

- **5. Minutes of WASACRE Meeting 30 March 2012** A couple of changes were made.
- **6.** Collective Worship document A new draft of the document has been completed, following the comments and suggestions given by members. RT offered to check the Welsh translation of the document again in light of the minor amendments. Members agreed that the document is extremely valuable and they were very happy with the document being sent out to schools and to Estyn. It was confirmed that Estyn will be inspecting RE separately, but no details of how this will be conducted have been made available. Members looked at some exemplar case studies provided by LJ and BJ to support the collective worship document. It was decided that Bethan would email TaS an electronic copy of one case study for distribution to advisors on NAPfRE.

- **7. WASACRE Survey of SACRES in Wales** A copy of the draft report were distributed to members. TaS highlighted the importance of the Next Steps section-recommendations to SACREs. It was agreed that a copy would be sent to the first minister for Wales, in response to correspondence earlier in the year with him. It was agreed that a list of recipients needed to be included. All members were happy for TaS to complete writing up the report and to email it to them for comments before the next WASACRE meeting on June 26.
- **8. REQM** The value and purpose of the RE Quality Mark in a Welsh context was discussed by members. TaS would follow up questions relating to funding issues. Members agreed that this should be referred to NAPfRE.
- **9. SACRE Reports** It was agreed that TaS would contact the Welsh Government (DM) about the need for WG to provide details concerning the possible new format for SACRE annual reports. The need for consistency across the SACREs was stressed and also the need for annual reports to reflect appropriately the work of SACREs.
- **10.** Representing WASACRE on EFTRE (European Forum for Teachers of RE). WASACRE is represented on EFTRE by DM, who is no longer able to hold this role. Members discussed future representation on EFTRE. It was agreed that there should be a costing for the role over a 2 to 3-year period. The costing would include expenses only with particular reference to the conference, which takes place every three years. Members agreed that this was a valuable relationship to continue.
- **11. KS3 Moderation** This was referred to the Executive at the 30 March WASACRE meeting. In relation to teacher support after the completion of the exercise, members decided to continue to monitor the situation until there is more information about the results of the process. It will be helpful to have feedback from GC at the next Executive meeting.
- 12. Correspondence In addition to that covered in previous agenda items: Jim Stewart and the collective worship petition showed the support present for the continuation of collective worship in schools. A response had been received from Leighton Andrews saying that he was unable to meet with representatives from WASACRE at present, but would be pleased to attend a WASACRE conference which was proposed in the last meeting with the Minister. It was decided that summer (June/July) 2013 might be a good time for the conference, linking with the results of the Estyn thematic review.
- **13. Agenda for Llandudno Junction WASACRE meeting, 26 June** Various items needed confirmation for the meeting. BJ and TaS to follow these up.

# Report of the activities of the Association 2010 – 2011

- 1. The Association met on three occasions: 24 June 2011 on Anglesey, 24 November 2011 in Cardiff, and 30 March 2012 in Ceredigion. We are grateful to the hosting SACREs for their generous hospitality.
- 2. The Executive Committee met on three occasions: 5 October 2011 in Cardiff, 27 February 2012 in Cardiff, and 24 May 2012 in Wrexham.

The Executive Committee had a full agenda throughout the year that included:

- (h) producing and circulating a guidance document on statutory collective worship in schools, which identifies characteristics of educationally meaningful and effective collective worship as well as the legal requirements for collective worship;
- (i) working with NAPfRE to produce case studies supporting the guidance document on collective worship, which will also be made available on the WASACRE website, www.wasacre.org.uk;
- (j) producing and circulating an abbreviated version of the REsilience Project Report, with a focus on the performance of REsilience in Wales;
- (k) finalising the document, SACREs and the Local Community: report of the WASACRE survey of SACREs in Wales to present to members at the June 2012 meeting of the Association;
- (l) discussing and responding to questions relating to the Key Stage 3 Moderation process in relation to Religious Education in Wales;
- (m) discussing and responding to questions relating to membership of SACREs;
- (n) representing WASACRE on committees and events of relevance to the work of the Association, for example, the RE Council for England and Wales, NAPfRE, EFTRE (the European Forum for Teachers of Religious Education), the Inter Faith Network for the UK, and the Launch of the All Party Parliamentary Group on Religious Education at the House of Commons (11 June 1012).
- **6. Accounts.** The Treasurer's Report for the 2010/2011 financial year. During the year, income exceeded expenditure by £2184.37 which was a further improvement on the position in 2009/2010 when the income exceeded expenditure by £1619.65. The financial year commenced with a balance of £12754.85 and ended with a balance of £14939.22. The finances of WASACRE, therefore, remain in a healthy condition,

having improved on the position at the end of 2009/2010, and this will assist WASACRE in funding its planned activities. Members received and adopted the statement of accounts.

Members accepted the Treasurer's recommendation that the annual subscription per SACRE for membership of WASACRE during 2011/2012 financial year be set at £400, which represents an uplift of 2% on the 2010/2011 subscription. With regard to payment of expenses, members agreed to raise the expenses' payment per mile from 40 pence to 45 pence. A copy of the financial report was made available to SACREs.

- 7. New members of the Executive Committee. At the summer 2011 AGM, it was confirmed that the Vice Chair, Edward Evans, would take the position of Chair of the Association and Tania ap Sion would take the position of Vice Chair of the Association. Tania ap Sion would continue in the role of Secretary until the 2012 AGM meeting, where Libby Jones (Assistant Secretary) would take the position of Secretary. Two members were elected to the Executive Committee for the period of 2011-2014: Vicky Thomas (Torfaen) and Brian Rogers (Rhondda Cynon Taf).
