***“In 2011, it will be the former County of Caernarfonshire, namely a part of Gwynedd and part of the County of Conwy that will be sponsoring the Royal Welsh Show at Builth Wells. Efforts are underway across the county to raise money to promote the show and to make it a successful and memorable festival.***

***In view of this, parents and teachers along with others working in our schools have highlighted the difficulty facing them because of the school holidays in Gwynedd and Conwy.***

***The show will be held from Monday until Thursday, that is, from 19 - 22 July. Unfortunately, as arrangements currently stand, the schools do not close until 21 July 2011 and this could have a substantial detrimental effect on Gwynedd residents along with attendance at the showground. In the face of common sense and for everyone’s benefit, I propose that Gwynedd schools, like other schools in mid and south Wales, close on the Friday, 16 July 2011.”***

***In view of the fact that the Ferodo site near Caernarfon has now been eliminated from the process (which is disastrous news for the economy of Gwynedd), it is imperative that Gwynedd Council does not lose the initiative in vigorously pursuing this objective”***
