RESOLVED

- (a) to cease the use of Hafod y Gest as a residential home timed in accordance with the development timetable of the extra care housing on the site;
 - (b) to ensure that assessments of the existing residents of Hafod y Gest are held and to re-home the residents in accordance with their individual needs;
 - (c) to submit a report to the Board on transferring the site to Cymdeithas Tai Eryri, free of charge;
 - (ch) to support the Portfolio Member and the Corporate Director to submit a formal application to the Welsh Government to redirect the social housing grant allocated to build Extra Care Housing in Llan Ffestiniog to develop Extra Care Housing schemes in Porthmadog and Bangor
 - (d) that the provision meets the residential needs and follows best practice in order to enable the individual to maintain their home, including people suffering from dementia, and to continue in close collaboration with the University and Professor Bob Wood;
 - (dd) to look at day opportunities and ensure that the third sector leads on this;
 - (e) to support Cymdeithas Tai Eryri's intention to consult locally on the detailed design prior to submitting a planning application.
