- (b) Harbour Development. A walkway between the main bridge and the harbour to join up with the coastal path from the north would bring in an enormous amount of business from known high spending cyclists.
- (c) A harbour model to find out where the flows are and what can be done to improve the harbour, again to bring in businesses and tourists.
- (d) Harbour Act 1797, Barmouth Urban Council 1929, and the public enquiry in 1969 should all be considered
- (e) The sewer pipe still needs to be shortened. Can we put pressure on the Water Board?
- (f) Can pressure be put on the Council to do something about the toilets which are still appalling.
- (g) Fendering on the ladders.
- (h) Rod fishing from the harbour wall should be policed more than it is.
