7. **Matters to be considered at the request of members on the Advisory Committee**

To receive verbal reports from appropriate officers on the following matters:

- (a) What traffic calming/control measures could be put in place to improve safety for pedestrians using the harbour and for those accessing the quays and slips with watercraft and equipment?
- (b) Concerns expressed by users about the structural integrity of the quay and quay wall. The view was expressed that there are substantial "voids" within the structure partly as a result of "hydraulic mining" of fines during rough weather.
- (c) Consider "ploughing" the harbour near to the quay wall so as to mobilise sediment which would be taken away on the ebb time. This would allow the profile near to the quay wall to be flattened so that boats do not tip away from the wall when they settle at low water. A local user has offered to do this using his own equipment providing that his fuel (diesel) costs are met.
- (d) Consider making provision of a "foot bath" and foot scrapers to allow users, such as operators of personal water craft, to wash of sand before using harbour facilities or accessing buildings.
- (e) Consider, at a more strategic level, the long-term development of the harbour to include a wide range of options to be built up from both stakeholder and independent views and evidence.

- (f) The user group would like to give their support to a policy of removing mooring equipment for which the rent / fees due to Gwynedd Council have not been paid
- (g) Concern as to condition of plinth at the bottom of ferry steps
- (h) Tenders on dinghy rack need to be secured
- (i) Visitor berths / berthing on pontoon
- (j) Slime on the main slip
- (k) Red Flag
