Our, shop is a kebab, pizza, burger take away. We do not sell alcohol on the premises.

b) The prevention of crime and disorder

We do not tolerate any form of misbehaviour. We are very fortunate not to experience any major problems. We operate a C.C.T.V. camera system for the customers' protection as well as our own. On some occasions we have called the police for minor happenings, but we also borrow our recordings to the police, to assist them in other matters, not relevant to our business. We also have doorpersons to coincide with the terms of our licence.

c) Public safety

We did fit a ramp for easy access in and out of the shop one time, we found that people were tripping, up and therefore had to remove it, and replace with steps once again. We also have fire extinguishers fitted and we check them regularly.

d) The prevention of public nuisance

The noise and disturbance on Holyhead Road Upper Bangor, is minimal compared to other areas. We have had no serious complaints. We have a ventilation pipe on the roof, but it is quiet. We have a commercial bin and we

keep our area very clean. We do not park in alley way

e) The protection of children from harm as it would restrict student access.

Our shop is a take away, and regular family customers visit us at a regular basis. There is no danger or any harm caused to the public at all in our shop.





Door Supervisors

- The Designated Premises Supervisor will maintain a register, approved by the Police and Local Authority, of all Door Staff employed on the premises. The register will include the times each person working as door staff started and finished duty, their SIA badge number and if not directly employed by the Designated Premises Supervisor, the name of the company that employs them.
- The register will remain permanently on the premises and be made available for inspection on demand by the Police or Local Authority. On completion of the register it will remain on the premises for a period of at least one year from the date it was completed and for that period of time remain available for inspection by the Police or Local Authority.
- A minimum of one SIA registered door supervisor will be employed at the premises every Thursday, Friday and Saturday night for the terminal hour when licensable activity is permitted under this licence..
