



We will always ensure that the premises will follow all regulatory guidelines regarding licensing of the premises. The staff we will employ will always be up to date with being legal and compliant regarding licensing matters. Which will include training with the sale of alcohol, identifying when a guest has consumed enough alcohol and the sale of alcohol to anyone under age,

b) The prevention of crime and disorder

Any incident will always be logged down. And if judgement is made that any incident is in breach of the law, the police will be called. On top of this, CCTV will be installed and operational at all times -

- 1. Digital CCTV system will be installed and working to the satisfaction of the Police and Local Authority monitoring both the interior and exterior of the premises.
- 2. In the case of the interior of the premises there will be sufficient cameras to cover all areas to which the public have access, with the exception of the toilets.
- 3. Lighting in the location must be of sufficient brightness and quality to identify persons within the location on the CCTV system.
- 4. The CCTV system will record and retain images of all times when members of the public are on the premises, for a minimum of 28 days.
- 5. Images will be surrendered on request of the police or local authority at the time the request is made and the premises will ensure they keep sufficient software available to comply with this condition.
- 6. There must be a minimum of one member of staff trained and available to download evidence at the request of the Police or an authorised officer at all times the premises are open.
- 7. CCTV warning signs shall be fitted in public areas of premises.
- 8. Recordings of incidents must be made secure for inspection by police.

c) Public safety

We will follow and adhere to strict fire safety policies. We will be under the supervision of a local fire protection service. Fire distinguishers of the necessary sort will be at an arms distance on every floor. Along with the installation of exit signs and fire alarms.

d) The prevention of public nuisance

Though we will be a resepectable restaurant - we will ensure that our guests will leave the establishment in a respectabe manner. We will also always make sure that bottle bins are emptied at a reasonable hour - so not to disturb our neighouring houses/businesses. The same will apply to our deliveries. It is already in place that delivery of our goods will also be at a reasonable hour.

e) The protection of children from harm

We will follow the challenge 25 policy where anyone who looks 25 or younger will be asked to provide an acceptable form of ID. Forms of ID accepted are - passports, driving licenses and GOV approved ID. All must be photo identification.

Team members will also have to undergo Underage Sales Prevention training.

We will also keep a register of anyone who tries to buy alcohol under the age of 18.
