

From 1995 to 1996, I lived in Treborth Mews which is a hundred yards from where the road to Treborth Hall starts. I used to walk the route in question daily on my way to work in Menai Bridge. Since this, we have moved to live in the Belmont area of Bangor and have been walking the path regularly to attend the son's football practices, walk to the Botanic gardens in Treborth as well as visit the running track.

I have included photos taken as we walked along the road when the son was very young. We have probably walked this road hundreds of times over the years.

Until May 2021, no one has said a word to us about walking along this road. When one of the residents tried to stop us, my husband and I thought he was joking.

We were so angry that a young man tried to scare us and threaten us using the law while walking silently along a road we have walked for years. I am aware that there are similar stories from several people.

The situation is causing a lot of resentment.
